- 5. Presentation of Financials and 2010 Budget.
 - The 2009 Financials are posted and can be accessed on the SGCA website.

- The 2010 budget was presented with a projected deficit of \$1,555.00 which will be absorbed through reserved monies. Total Revenue expected to be \$23,875.00 with expected expenses to be \$25,430.00. One of the reasons we are seeing a deficit is that we no longer have brand new homes being built in this area which used to generate an extra \$400 per house upon the initial closing date after construction of a new home. Motion to accept 2010 budget made by John Mellor and 2nd by Brian Campbell. All attendees voted in agreement.
- Request to continue using Ronald J Van Dam as our Certified Management Accountant for financial reports. Motion made by John Mellor and 2nd by Brian Campbell. All attendees voted in agreement.
- 6. Questions/Concerns?? (Open floor discussion)
 - Ivan Pejokovic commented about low attendance. Of the 275 households, very little attendance continues to occur. At the AGM on May 13th, only 12 members were in attendance. Mailings were sent to all 275 households along with a follow up e-mail reminder to the households that are on our e-mail distribution.
 - Ivan made presentation on behalf of Jamie Pabowki and himself; where by these two residents had installed on their own board walks off of Lantern Street that runs through the woods and behind Deer Ridge Golf Club.  - Ivan had a series of additional questions which were addressed including:

Q-Why do Deer Ridge Estate residents not contribute towards maintenance of entrance?

A-Our board of directors have attempted to engage Deer Ridge Estates to assist with the maintenance of the entrance, however due to the objectives of each association being different, Deer Ridge Estates is focused on Fund Raising events and Settler's Grove Association is focused on landscaping maintenance of the entrance to Deer Ridge Drive. Q-Why are there no places or events where teenagers can participate? A-The parks in our neighborhood are the property of the City of Kitchener and we are not permitted to alter or enhance the parks without their permission. Currently Kuntz Park (by Pioneer Tower) has a project underway that will introduce numerous enhancements for the enjoyment of all residents including; tennis courts, an outdoor ice rink and neighborhood garden. As well, we have been working with the City of Kitchener in attempts to acquire land for a possible soccer field. This is still underway. Another idea that was requested to be explored is the possibility of installing a basketball hoop at Settler's Grove Park as this is much needed for teenagers.
